

ARCHIDEX RIDE & WIN

Terms & Conditions

By taking part in the ARCHIDEX RIDE & WIN CONTEST herein (the “Contest”), all persons participating herein (the “Participants”) agree to be bound by the Terms and Conditions as listed below;

1. CONTEST PERIOD

- 1.1 The Contest period run from **29 July – 1 August 2026**.
- 1.2 The Contest Submission Deadline ends on **1 August 2026 (Saturday) at 7.00PM**. All participation or entries received after the date and time stated shall not be entertained and will be deemed invalid and immediately disqualified.
- 1.3 The Organiser reserves the right to shorten or extend the Contest period without prior notice.
- 1.4 The Organiser reserves the right to cancel, modify, suspend, or amend the Contest Terms and Conditions at any time without prior notice.
- 1.5 The Organiser is not, and shall not be held, responsible for any technical malfunction in connection with the Contest.
- 1.6 All decisions of the Organiser on all matters relating to the Contest are final, and no further correspondence will be entertained.

2. CONTEST ELIGIBILITY

- 2.1 The Contest is open to all individuals aged 18 years old and above at the time of the entry, including Malaysian citizens and non-Malaysians holding a valid passport.
- 2.2 Employees of the Organiser and its Affiliates, Sponsors, Agencies, Contractors, Suppliers, Exhibitors, and their immediate family members are not eligible to participate.

3. CONTEST CRITERIA AND MECHANICS

- 3.1 Participants are required to utilise the official ARCHIDEX free shuttle bus service during the exhibition days to be eligible for entry.
- 3.2 All participants are required to follow the steps using their personal Facebook accounts to qualify. The steps include:
 - 3.2.1** Capture a **selfie** with our Llambo mascot poster visual inside the shuttle bus during your ride.
 - 3.2.2** Post the photograph on their **personal Facebook and/or Instagram profile**.
 - 3.2.3** Tag the official ARCHIDEX Facebook page at **@archidex.my** in the post;
 - 3.2.4** Include the mandatory campaign hashtags: **#ARCHIDEXRIDEANDWIN**, **#ARCHIDEXshuttle**, and **#ARCHIDEX2026**.
 - 3.2.5** Participants must ensure their Facebook and/or Instagram profile feed or profile privacy to is set to **“PUBLIC”** for the duration of the Contest to facilitate entry tracking.
- 3.3 Each Participant may submit an unlimited number of entries, provided that the Contest criteria set out in Clauses 3.2.1 – 3.2.5 are fulfilled before the submission deadline. Notwithstanding the number

of entries submitted in relation to the Contest post published by the Organiser, only ONE (1) winner will be selected for the prize.

- 3.4 Participant who do not meet the eligibility requirements or who are subject to any entry restrictions shall not be entitled to be selected as a winner or to receive any prizes under any circumstances.
- 3.5 The Organiser's decision in respect of all matters relating to the Contest shall be final, and no correspondence will be entertained.
- 3.6 The Organiser reserves the right to disqualify the Participants and/or revoke the prize at any stage of the Contest if:
- 3.6.1** There is any discrepancy in the Participant's eligibility or if the Participant does not meet any of the Contest criteria;
- 3.6.2** The Participant breaches the Terms and Conditions or other rules and regulations of the Contest;
- 3.6.3** In the Organiser's sole discretion, it determines that the Participant has attempted to undermine the operation of the Contest by fraud, cheating, or deception; or
- 3.6.4** While the Organiser will endeavour to carry out the necessary verification of a Participant's eligibility, any failure to disqualify an ineligible Participant shall not be deemed a breach by the Organiser.

4. CONTEST PRIZE & WINNER ANNOUNCEMENT

- 4.1 The designated prize type and value are fixed as specified below. The Organiser reserves the right to substitute the prize with an item of equivalent value at its absolute discretion:

- 4.2 All winners of the Contest will be randomly selected and announced via Announcement Post on the **ARCHIDEX Official Facebook Page**.
- 4.3 The Organiser's decisions on all matters relating to the Contest shall be final, conclusive, and binding. The Organiser shall not be obliged to provide any reasons or enter into any correspondence with any person in relation to the Contest, including the selection of winners.
- 4.4 All winners are required to respond **within twenty-four (24) hours** of the respective announcement post time via a private message on Facebook Messenger through the ARCHIDEX Official Facebook Page to arrange the logistics for their prize redemption..
- 4.5 If the Organiser does not receive a validation response from the Winner by the stated deadline, the prize will be forfeited, and the Organiser reserves the right to select an alternative winner without prior notice.
- 4.6 In the event that the identity verification or physical collection is mandated by the Organiser, the prize must be claimed personally by the winner at the **designated Visit & Win counters @ Hall 4 (Level 1), Hall 7 (Level 2), Hall 11 (Level 3)** at the **Malaysia International Trade and Exhibition Centre (MITEC)**, Kuala Lumpur, during the exhibition operating hours of 10AM to 7PM from 29 July – 1 August 2026.
- 4.7 Only the verified winner is allowed to collect the prize. In the event that the selected winner is unable to collect the prize in person at ARCHIDEX, collection by a representative and/or delivery by post shall not be permitted, and the winner shall be deemed to have forfeited all rights to the prize. In such

event, the Organiser reserves the right to select the next eligible winner at its sole and absolute discretion.

- 4.8 At the time of prize collection, all winners must provide the Organiser with the following personal particulars for verification purposes and further arrangements with participating sponsors of the contest:
- 4.8.1: **For Malaysians:** Full name as per NRIC, NRIC number, and a valid mobile phone number linked to a verified Touch 'n Go eWallet account, and an email address.
- 4.8.2: **For Non-Malaysians:** Full name as per Passport, Passport Number, and a valid mobile phone number linked to a verified Touch 'n Go eWallet account, and an email address.
- 4.9 In the event that the announced prize is unavailable, the Organiser reserves the right to substitute or replace the prize with another item without prior notice. All prizes are non-transferable, non-refundable, and non-exchangeable and are not redeemable for cash

5. GENERAL

- 5.1 The Organiser shall not be liable for any other consequences or any unforeseen circumstances arising from and/or in connection with the Contest and/or the redemption or use of any prize.
- 5.2 By participating in the Contest, the Participant is deemed to have given consent to the Organiser to collect, use, disclose, and store the Participant's personal data for the purpose of organising and administering the Contest
- 5.3 The Organiser reserves the right, at its sole and absolute discretion, to use the nicknames, names, photographs, voice or video recordings, and entries of the Contest Winner(s) for publicity, advertising, trade or promotional purposes in any media, without prior notice, consent or payment to the Contest Winner(s)
- 5.4 A Participant may revoke his or her consent to the storage of personal data by contacting the Organiser via the ARCHIDEX Official Facebook Page. Upon such revocation, the Participant shall be deemed to have withdrawn from the Contest
- 5.5 The Organiser will use its best endeavours to keep all personal data of the Participants strictly confidential, except for the names of the winners, which may be published on the ARCHIDEX Official Facebook Page
- 5.6 All personal data received will be processed in accordance with the Personal Data Protection Act 2010 (PDPA)
